Drinking Fountain

Fixture is designed to be installed and serviced from the front of a finished wall. Fixture is fabricated from 16 gage, type 304 stainless steel and is seamless welded construction with a satin finish. Bottom of unit includes removable enclosure.

Countertop has a deck-mounted bubbler with mouthguard.

Bowl is oval. Standard close elbow waste outlet is 1-1/4" O.D. plain end.

Valve is an Air-Control pneumatically operated, non-metering, self-closing type. All exposed trim is chrome-plated. Valve has a 0.7 GPM flow control. Valve and bubbler conform with the lead-free requirements of NSF61, Section 9,1997 and CHSC 116875.

Regularly furnished items include an Air-Control self-closing valve, a bubbler with mouthguard, a grid strainer with close elbow and a mounting bracket. Screws and anchor shields by others.

GUIDE SPECIFICATION

Provide and install Acorn Dura-Ware Drinking Fountain (specify model number and options). Fixture shall be fabricated from 16 gage, type 304 stainless steel. Construction shall be seamless welded and exposed surfaces shall have a satin finish. Fixture shall be furnished with an Air-Control self-closing valve, a bubbler with mouthguard, a grid strainer with close elbow, and a mounting bracket. Valve and bubbler conform with the lead-free requirements of NSF61, Section 9,1997 and CHSC 116875. Installer shall furnish mounting screws, anchor shields, and required reinforcement.

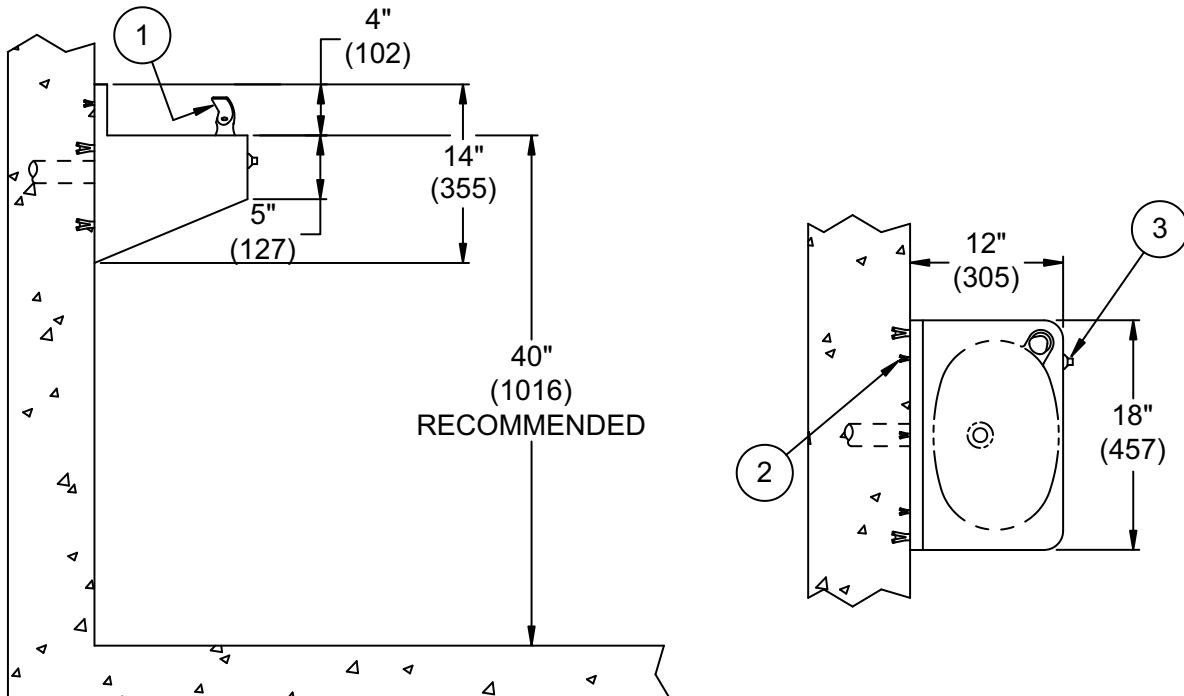
