Acorn Terrazzo Uni-Lav - 1 Station - ADA Compliant

Bowl and Sprayhead are reinforced cast Terrazzo. Bowl is 20-3/8" (518mm.) wide, and has an integral Backsplash and Sprayhead. Bowl is finished with a clear polyurethane coating. Standard color is Palomino Tan. See available color selection.

Barrier-Free Conformance

Units conform with ANSI, UFAS, ADA and OBC requirements for accessibility. Compliance is subject to the interpretation and requirements of the local code authority.

Hand Pushbutton (suffix option -H) operates an individual non-hold open, Air-Controlled Metering Valve and can be field set for flow ranging from 5 to 60 seconds. Pushbutton requires less than 5 pounds of force to activate valve.

Electronic Sensor Operation (suffix option -SO) includes individual Solenoid Valves activated by Infrared Sensors. A plug-in style Transformer is provided.

Foot Pushbutton is not available on this model.

Spray Nozzle is vandal-resistant and provides a concentrated 0.5 GPM spray.

Hot & Cold Supplies are blended in an ASSE 1070 compliant temperature/pressure balancing Mixing Valve with Integral Checks and Strainers. A minimum of 30 PSI supply pressure is required.

Shroud is heavy gage, stainless steel.

GUIDE SPECIFICATION

Provide and install Acorn Terrazzo Uni-Lav (specify model number and options). Bowl shall be reinforced cast Terrazzo polished and sealed with a clear polyurethane coating, and shall have an integral Backsplash and Sprayhead. Spray Nozzle shall be vandal-resistant type with 0.5 GPM flow control. Provide an ASSE 1070 compliant temperature/pressure balancing Mixing Valve with Integral Checks and Strainers in hot and cold supply and field set water temperature at 105 degrees Fahrenheit. Shroud shall be heavy gage, stainless steel. Terrazzo Uni-Lav shall be mounted using Carrier Arms, supplied by others. Units to conform with ANSI, UFAS, and ADA requirements for accessibility.




